Camp Registration Info

Registration:

When registering for programs, please use your camper's grade level as of the 2020/21 school year, except for day camp kindergarten-level programs, which are open to girls currently in, or entering kindergarten in fall 2021.

PAPER: Use this form to register (one per camper), then mail or bring into our offices in Bedford, New Hampshire or Williston, Vermont.

ONLINE: Visit girlscoutsgwm.org and click the CAMP tab to register. Online registration is completed in real time, and is best used for programs that might fill quickly. New to Girl Scouts? Register as a member online under our JOIN NOW tab.

Program Waitlist:

Most programs will have a waitlist; register to the waitlist. If programs can be increased, we will do so and you'll receive notification that you have been added to the program. If programs can't be increased, we'll contact you to try to find an alternative program or week. If the program is full and does not have a waitlist, the spaces cannot be increased; contact us if you need assistance to find an alternate program or a week that works for you.

Cookie Program Credit use:

Planning to use Cookie Program Credit to pay for camp? Cookie Program Credits may be used to pay for camp fees. Unfortunately, refunds cannot be provided for Cookie Program Credits received after your final payment has been made. Cookie Program Credit will be issued May 5.

Financial Assistance:

Financial Assistance is available to qualified families with girls living in New Hampshire and Vermont. Families can apply for assistance for up to 2 one-week camp sessions or 1 two-week camp session per year. Once the deposit is paid, submit the Financial Assistance Request Form with the required documents. Applications are reviewed and families contacted with reward information; funding is limited and not all requests can be granted. If the request is not granted, the camp deposit can be refunded. All awards are confidential, and camp staff are not aware of who received or applied for financial assistance. Please contact us for more information.

Refunds and Cancellations:

If you cancel a registration before May 28, program fees will be refunded (minus the \$50 per session deposit). After May 28, refunds of program fees (minus the \$50 per session deposit) may be made only for cancellations due to a camper illness verified in writing by a doctor, or a serious family emergency. Registrations are not transferable to another girl. No reduction in fees can be made for girls arriving late or leaving early for any reason, including campers who leave for disciplinary concerns.

Final Payment:

Once the deposit is paid and your camper is registered, invoices for balances due are sent. You can make payments, use Cookie Program Credits, or make a decision based on a financial assistance application through May 28, when all balances are due. Families with outstanding balances after May 28 will be contacted, and if there are waitlists for programs, may be removed from programs for non-payment. Campers will not be permitted to attend camp if there is a balance due for any session.

Camp Health Info

The health and safety of campers and staff is our first priority. Our health care policies meet or exceed standards set by Girl Scouts of the USA's guidelines, state licensing requirements, and American Camp Association (ACA) guidelines. Our camp staff are trained in first aid, CPR, and other health care certifications as required by their positions. Physician reviewed standing orders are followed to provide care for our campers.

Camper health information is managed through health forms we will send to you. We ask that you turn in health forms ahead of camp, and note any information we will need to help your camper be healthy and successful at camp.
